We at SDMNY can write and talk at length about what supported decision-making is, where it comes from, what we do in SDM facilitation, and how the right to make one's own decisions, including having the supports necessary, is a human right, but there is nothing more compelling than the experience of doing SDM facilitation and practicing SDM told by the people, Decision-Makers, supporters and facilitators, who are actually doing it.

In presentations that SDMNY is asked to do for multiple audiences, we always try to include the voices of our Decision-Makers, although for practical reasons, that almost always happens remotely, and often through videos that the Decision-Makers themselves have made to express their views of SDM and tell their stories.[6/3/2022] For example, at the New York State Judicial Institute "New Judges School" held last month, when SDMNY Director (and former NY County Surrogate) Kris Glen and two SDMNY Advisory Council members, Surrogates David Guy (Broome County) and Peter Kelly (Queens County) presented about SDM, they were able to make it come alive-and very persuasive-through the videos made by Decision-Makers Jessica and Louis.
